FIRST ANNUAL SYMPOSIUM SUNDAY, JUNE 3RD, 3:30 PM

Symposium linguistically means "to drink together," but it also means a "free interchange of ideas." The latter is what we expect on June 3rd at the First Unitarian Church of Portland.

Commencing at 3 p.m. with refreshments and social time in the Channing Room, the symposium will then convene at 3:30 p.m. in Eliot Chapel, 1011 SW 12th Avenue in downtown Portland. (For directions and parking see www.firstunitarianportland.org.)

The opening topic of the symposium, **Planning an Appropriate Death:** From Before to After, will explore the meaning of the phrase "appropriate death" and present some practical steps a person can take with their family to prepare for an approaching death and for the after-death memorial.

Our program continues with **The Value of Ritual: Traditional and Changing.** The **Rev. Dr. Marilyn Sewell** will present her perspectives on end-of-life rituals, how they are changing, and how to meaningfully connect tradition and change. Reverend Sewell, Minister Emerita of the First Unitarian Church of Portland, is a writer, editor, and subject of the documentary, "Raw Faith."

The following guest speakers will each share an essential ritual from their own religious/ethnic tradition or personal experience:

- Elder Linda Meanaus, granddaughter of Celilo Chief Tommy Thompson, who may share a song or drumming from her longhouse tradition.
- Rabbi Daniel Isaak, Congregation Neveh Shalom, who serves as President of the Oregon Chapter of the Interreligious Committee for Peace in the Middle East
- Rev. Wendy Weinstein Fish, Chaplain, Legacy Good Samaritan Medical Center, and Minister Emeritus of Unitarian Churches in Ohio and California.
- **Shahriar Ahmed,** President, Bilal Mosque, Beaverton, Oregon, who found his voice as Muslim spokesperson on 9/11. Ever since, Bilal Mosque has held an open house on September 11th.

An interchange among these presenters seeking clarity, highlighting commonalities, and elaborating important concepts will ensue before the audience is invited to engage in the dialogue and share in what promises to be a rewarding and perhaps inspiring experience. Please plan to attend!

CONTRACTS EVALUATION AND PORTLAND AREA PRICE INCREASES

Much has changed in the funeral industry during the fifty years since Funeral Consumers Alliance of Oregon-Oregon Memorial Association was formed. There is both more integration of funeral homes with cemeteries and crematories and more small-scale specialty providers often associated with the cremation industry. Just as importantly, attitudes have changed about end-of-life choices. Today fully 70 percent of the deceased have chosen cremation. Former traditions like home preparation and ceremonies are returning to favor. And "green" practices like simple burials without embalming are more often followed.

FCAO decided recently to undertake a review of its current contracts to address these changes and other considerations. Our first action, taken in the interest of our 12,000 members, will be to visit each contract mortuary to review carefully the current contract provisions, the contractors' experience under the contract, and the relationship between contractors and FCAO. This step will lead to an investigation of options for expanding our contract coverage to other parts of the state and, potentially, to adding contract mortuaries in areas already served by an FCAO contractor. Finally, and more long-term, we will evaluate our current contract model to determine whether modifications should Your responses provided by the Membership Survey on page 4 in this newsletter will help us during this evaluation.

Recently, our Portland-area Contract Mortuary, River View Cemetery, requested an amendment to the price for each of the six service packages. FCAO has considered this request and acted to amend the contract with River View. In addition to the price increases, an amendment adding an audit clause was approved. The new prices, effective June 1, 2012, are as follows:

River View Package Prices	
Direct Burial	\$1,090
Simple Graveside Service Without Embalming or Visitation	\$1,500
Traditional Funeral Service in Funeral Home Chapel with Burial	\$2,745
Direct Cremation, No Service	\$795
Direct Cremation with Memorial	\$1,210
Traditional Funeral Service in Funeral Home Chapel with Cremation	\$2,910

THINGS YOU SHOULD KNOW ABOUT FINAL WISHES

Most of us probably know that Oregon's Personal Preference law obliges survivors to honor the written wishes of the deceased. Many of us may not know that we also have the option of naming the person to whom we have given this responsibility.

Oregon's law (ORS 97.130(3)) permits you to name a designated agent for body disposition using a "Directive Regarding Disposition of Remains." Because your wishes must be written out, you have the opportunity to thoughtfully plan your final arrangements and to make choices that are meaningful to you.

To help aid in your planning, FCAO recommends the booklet <u>Before I Go, You Should Know</u>, a detailed and helpful resource. It is a publication of the national Funeral Consumers Alliance and is included in the end-of-life planning kit you can purchase from FCAO (Price: \$12.00; order one by contacting FCAO by letter or e-mail.)

A similar help is the Personal Instruction Form (PIF) that FCAO distributes to members when they join. Members are asked to specify the mortuary of their choice along with disposition and service preferences. The PIF is a simple way to express your final wishes, make the essential prearrangements, and achieve peace of mind.


Of course, you, your family and/or designated agent should understand how much your wishes will cost. You should not expect anyone to pay for a costly funeral if you don't set money aside for that expense. (We'd like to acknowledge the Oregon State Bar as the source for material about Oregon's Directive Regarding Disposition of Remains.)

During the past year, our members have been very generous in support of our Education Foundation research and education endeavors.
