Review, Revise, Resubmit

Your Oregon Memorial Association can best help you and your survivors if your information on file with us is up to date. Help us update your file by reviewing your Personal Instruction Form (PIF); revising any information on it such as address, phone, email or new end of life instruction; finally, resubmit the form to us to scan and add to your file. Then when your next of kin calls us, we'll be able to share your wishes.

You can find this important form on our website at www.fca-oregon.org – select the "Join OMA" tab, then in the middle of the page you'll see a green tab that says PIF. Click on the tab and you'll go to the instruction form. Print as many as you need then complete them and mail to OMA, PO Box 13306, Portland, OR 97213.

Plan now to attend OMA's annual meeting June 18

Opening the afternoon will be a special, timely presentation on funeral home ethics and practices presented by Michelle Sigmund-Gaines, the Executive Director of the Oregon Mortuary & Cemetery Board, the state agency that supervises the industry and enforces the law. This will be a unique educational presentation that will be of value to all consumers.

The program will help OMA members understand how the industry operates, how it has changed in recent years – everything an informed funeral consumer needs to know. She will be aided by some funeral directors who will respond and discuss her remarks.

The program will be held Sat., June 18, beginning at 1:30 p.m. in the auditorium at Willamette View Retirement Center, 12705 SE River Rd., Portland, Oregon. The auditorium is located in the largest building and parking is plentiful.

After the program presentation there will be a break for refreshments and visiting, followed by a very short OMA business meeting that will include election of Board Trustees. Financial reports will be available at the meeting.
