Oregon Memorial Association Agreement with Cornerstone Funeral Services & Cremation

CREMATION

1. Bio Cremation (Aqua-cremation).....\$1,300

Includes basic service of funeral director and staff to obtain required authorizations including notifying social security and contacting primary care for signing of death certificate and overhead costs for:

- Transportation from place of death to refrigerated holding facility
- Refrigeration (required by law after 24 hours)
- Aqua Cremation Process
- Basic Plastic Urn

This option includes the \$30 Oregon State Filing Fee.

2. Direct Cremation; No Service.....\$700

Includes basic services of funeral director and staff; transfer of deceased to funeral home (within a 30-mile radius); care and handling of deceased, including refrigeration; crematory fee; an enclosed, rigid, combustible container meeting the minimum requirements of the crematory; and delivery by service vehicle to local crematory (within a 30-mile radius); OMA Administrative fee; one certified copy of the death certificate; and the Oregon State Filing Fee.*

3. Direct Cremation with Visitation Service.....\$1,200

Includes basic services of funeral director and staff; transfer of deceased to funeral home (within a 30-mile radius); care and handling of deceased, including refrigeration; crematory fee; embalming; visitation in chapel; vinyl memorial book; an enclosed, rigid, combustible container meeting the minimum requirements of the crematory; and delivery by service vehicle to local crematory (within a 30-mile radius); OMA Administrative fee; one certified copy of the death certificate; and the Oregon State Filing Fee.*

4. Traditional Funeral Service in Funeral Home Chapel with Cremation.....\$2,500

Includes basic services of funeral director and staff; transfer of deceased to funeral home (within a 30-mile radius); care and handling of deceased, including embalming and preparation for viewing; use of funeral home facilities for visitation and funeral service; staff for supervision of visitation periods; coordination and direction of funeral ceremony in funeral home chapel; vinyl memorial book; Matthews Sentry 20 gauge steel casket (or comparable casket of equal or greater value); transportation by service vehicle to local crematory (within a 30-mile radius); crematory fee; OMA Administrative fee; one certified copy of the death certificate; and the Oregon State Filing Fee.*

BURIAL

1. Direct Burial; No Service.....\$1,600

Includes basic services of funeral director and staff; transfer of deceased to funeral home (within a 30-mile radius); care and handling of deceased, including refrigeration; an all-wood, unfinished casket meeting the minimum requirements of the cemetery; private delivery by service vehicle to local cemetery (within a 30-mile radius); OMA Administrative fee; one certified copy of the death certificate; and the Oregon State Filing Fee.*

2. Simple Graveside Service Without Embalming or Visitation.....\$2,000

Includes basic services of funeral director and staff; transfer of deceased to funeral home (within a 30-mile radius); care and handling of deceased, including refrigeration; coordination and direction of graveside service at cemetery; Matthews Sentry 20 gauge steel casket (or comparable casket of equal or greater value); transportation by service vehicle to local cemetery (within a 30-mile radius); OMA Administrative fee; one certified copy of the death certificate; and the Oregon State Filing Fee.*

3. Traditional Funeral Service in Funeral Home Chapel with Burial.....\$2,700

Includes basic services of funeral director and staff; transfer of deceased to funeral home (within a 30-mile radius); care and handling of deceased, including embalming and preparation for viewing; use of funeral home facilities for visitation and funeral service; staff for supervision of visitation periods; coordination and direction of funeral ceremony in funeral home chapel; vinyl memorial book; Matthews Sentry 20 gauge steel casket (or comparable casket of equal or greater value); transportation by service vehicle to local cemetery (within a 30-mile radius); OMA Administrative fee; one certified copy of the death certificate; and the Oregon State Filing Fee.*

4. Green Burial Service.....\$1,300

Includes basic service of funeral director and staff to obtain required authorizations including notifying social security and contacting primary care for signing of death certificate and overhead costs for:

- Transportation from place of death to refrigerated holding facility
- Refrigeration (required by law after 24 hours)
- Transportation to Burial Space (within a 30-mile radius)
- Bathing, Shrouding, Casketing
- Sheet, Carryboard

This option includes the \$30 Oregon State Filing Fee and one certified copy of the death certificate.

***NOTES:**

a) The \$30.00 Oregon State Filing Fee will not be charged for deaths occurring outside of the State of Oregon.

b) The term "Basic Services of Funeral Director and Staff" is defined as: "Personnel available 24 hours a day, 365 days a year to respond to initial call; arrangement conference; coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased; clerical assistance in the completion of various forms associated with a funeral; securing and recording the death certificate and disposition permit; overhead, such as facility maintenance, equipment and inventory costs; insurance and administration expenses, and governmental compliance.

c) The mortuary staff will be clear with OMA members that the prices quoted for burial do NOT include the cost of the cemetery.
