We Are Here for You

Only two weeks earlier Judy had called OMA in a panic. "My aunt is in the hospital and the doctor thinks she may not come out again! I'm at her house going through her stuff trying to find any end-of-life papers and notes about possible funeral plans. I found a very old membership card with this number on it. I thought there'd be no answer, but (starting to cry) thank you for talking to me..."

Now OMA's Office Assistant, Margot, could rejoice with her. "Aunt Hazel pulled through, after all. I thought you'd want to know. You seem genuinely interested in

your members and I appreciate everything you were able to tell me. She's got nine lives, I guess, and aren't I lucky to have such tough, long-living relatives!?"

Keeping up with the constant changes in the funeral industry is challenging, but in Judy and Hazel's case, Margot had a note in our database about what Aunt Hazel wanted and which mortuary she preferred at that time. She checked with that mortuary to ask if Hazel had paid for a pre-need contract or policy there and, finding none, advised Judy on our current contracts and prices. Judy says she plans to get her own OMA membership and is considering a green burial or another more sustainable option for herself.



Judy had called, crying, "I found a very old membership card with this number on it. I thought there'd be no answer, but thank you for talking to me..."

Every month, Margot reports on calls she received, and they are varied. OMA is a valuable resource for hospices, senior center staff members, and the general public as well as OMA members. Almost every month she describes tracking down an old pre-need contract at a mortuary that no longer contracts with OMA or has been sold to another mortuary.

Saving the Planet, One Death at a Time

Around 60% of Americans choose cremation, and even more of us in Oregon at 79%. It is the most affordable of our choices. Many of us are now also contemplating the consequences of our body disposition choices.

Should we be considering the effects our decisions

have on future generations?

Can thoughtful body disposition choices help save the planet?

FACT: Body composting returns the carbon matter contained in each human to the earth rather than releasing carbon dioxide into the atmosphere.

FACT: Traditional flame cremation requires 2-3 hours at more than 1800 degrees of heat per corpse, releasing

573 lbs of carbon dioxide into the atmosphere. This is equal to driving 500 miles in a car, per *Chemical and Engineering News*.

FACT: Aquamation (aka "alkaline hydrolysis" or "resomation") is done at far lower heat by using high

pressure and chemicals that emulsify the body. Byproducts are biodegradable.

FACT: Aquamation usually costs about \$1,000 more than flame cremation.

FACT: Both types of cremation cost less than burial,

even green burial, due to the cost of cemetery plots.

FACT: While cremated remains are considered sterile and harmless, they can deter plant root growth due to high pH levels and excess sodium. A soil cremation mixture designed to lower both of these can be purchased to create a safe way to use them in your garden or other natural areas.

The Importance of Planning and Talking

You've planned, you've decided, and you've paid. You are sparing your survivors. But...are you? Many of us believe that it will relieve our survivors if our foreseeable funeral expenses are pre-paid. Pre-paying isn't always as fool-proof as we hope. We don't die where we thought we would, they don't have the coffin we chose, body disposition options keep changing, or survivors want a more sustainable option. If we haven't taught them how to make informed choices, if they do not know their funeral consumer rights, survivors are more likely to go into debt or have unexpected expenses. Planning is definitely needed, but talking is the most essential. Things to know:

- In Oregon all pre-need contracts must be revocable, unless the buyer is on Medicaid.
- If one is on Medicaid or applying for it, pre-pay to get funds out of one's estate, but seek legal advice first.
- Burial insurance can cost more than just setting aside funds in a "Payable at Death" bank account.
- Pre-paying locks in the price, but too often unexpected changes cost survivors more.
